The amount available for award(s) is normally a moving average of 2% of the fund's year-end values for three years. The Guild has not actively solicited contributions to the research award fund in several years, but every year receives some gifts, this year totaling \$1095. This year it paid \$11,050 in awards. Its principal at this fiscal close was \$256,598.

Line 1a

Most operational decisions are made by (1) a nine-person Board of Directors, or (2) the president or committees appointed by the board and the president. All directors have identical voting rights.

Members who are individuals may take a performance examination, which (if successful) advances them to the membership class (called Carillonneur Membership) with the highest voting rights. Only Carillonneur members may vote on the advancement of new Carillonneur members, and on changes to the Articles of Incorporation and Bylaws.

Line 6

The organization has members. It does not have stockholders.

Line 7a

Each year the members elect three people to the Board of Directors, to serve three-year terms.

Line 7b

All actions by the board of directors are subject to review by the members at the annual meeting. The advancement of new Carillonneur members, and changes to the Articles of Incorporation and Bylaws, require approval of the Carillonneur members.

Line 8a

Minutes are published of the annual meetings and any special meetings of both the members and the board of directors. All officers and committee chairs submit an annual report describing their activity since the previous annual meeting.

Line 19

The minutes of the annual meeting (containing the treasurer's report), the Articles of Incorporation and Bylaws, and this return are posted on the website.
